Notice Concerning Revision of the Dividend Forecast

Seven Bank, Ltd. (the “Company”) hereby announces that it resolved at a meeting of its Board of Directors held on February 6, 2015 to revise its per share dividend forecast for the fiscal year ending March 31, 2015 (fiscal 2014) as follows.

1. Reason for the Revision to the Dividend Forecast

The Company regards returning profits to shareholders as an important management issue, and with the aim of providing a fair return to shareholders, our basic policy is to strive to pay a sustained and stable cash dividend while maintaining an appropriate balance between dividend payments and internally retaining a suitable level of earnings. The Company targets a minimum dividend payout ratio of 35%. In line with this basic policy, the forecasted year-end dividend per share has increased 0.5 yen to 4.25 yen compared with the previous forecast.

As a result, the annual dividend per share for fiscal 2014 will be 8.00 yen, consisting of the year-end dividend and an interim dividend of 3.75 yen per share.
